# QUICK FACTS ABOUT THE TOCQUEVILLE SOCIETY:

- The Alexis de Tocqueville Society was formed in 1984 by United Way Worldwide.
- CAUW's local Tocqueville chapter was founded in 1986 with two charter couples, Huey\* and Angelina Wilson and Milton Womack\* and Margaret Hart.
- There are currently 26,000 Tocqueville donors worldwide in 16 countries, including Mexico, Romania, France, South Korea, Canada and several others.
- Since 1984, Tocqueville donors have raised over \$8 billion for their local communities, averaging \$266 million a year.
- There are currently 550 one-million dollar donors and 45 10-million dollar donors.




### **OUR WORK IN COMMUNITY IMPACT CONTINUES**

Traditionally, Capital Area United Way has invested in the direct impact approach of mobilizing the financial resources of businesses and employees to support direct services and improve the lives of program clients. This work is done by investing in programs and services that are focused on improving the lives of individuals and families. As CAUW looks to increase the impact on our 10-parish area, we have to become even more effective in improving lives, not just on an individual basis, but across our entire geographic footprint.

Community Impact is the approach that CAUW will use to mobilize the community's people, time, talent, relationships, expertise, technology, financial assets and other resources to change the conditions in communities that create so many problems for individuals and families, and thus improve the lives, not just of program clients, but of community populations.

# **VOLUNTEER INCOME TAX ASSISTANCE (VITA)**

Through the collaboration between Capital Area United Way and the Capital Area Asset Building Coalition (CAABC), we were able to provide the Volunteer Income Tax Assistance (VITA) program for yet another tax season. The VITA program provides free income tax preparation assistance and primarily targets low-income workers, the elderly, and individuals with disabilities. The VITA program also promotes financial stability by encouraging recipients to save refunds to start a savings account, pay off debt, or attend financial education classes.

This past tax season VITA site locations completed more than 5,101 federal tax returns, returning over \$7,442,213 million in total refunds. All of this was accomplished through more than 200 volunteers completing 7,888 volunteer hours all trained and certified by the IRS to perform a tax return. Through the use of volunteers, VITA is able to give individuals and families 100 percent of their hard earned tax return, which can be used to reduce debt, build savings and become more financially stable.


# THE GOTTLIEB SOCIETY

#### PACESETTER CAMPAIGN


